



DECLARATION, GUARANTEE AND GRANTING OF RIGHTS OF FIRST REFUSAL.

DECLARES, GUARANTEES AND GRANTS:

I.- That by signing this document, he/she is submitting the following material to SIX BIRDS PRODUCTIONS S.L. ("SIXBIRDS") with CIF B64632235 and address in Barcelona (08010), Ronda de Sant Pere 33 pral.:

All that is relevant to the project of which the provisional title is ".....," which is referred to successively in a joint and indistinct manner as the "PROJECT."

II.- The DEPONENT is submitting the PROJECT to SIXBIRDS, a company dedicated to the production of audiovisual work, with the purpose of the company reviewing the viability of the DEPONENT's audiovisual production during a period of no more than FOUR (4) months after the signing. SIXBIRDS may submit the PROJECT to a third party for the same purpose. In the event of lack of interest in the development of the PROJECT, SIXBIRDS shall destroy the submitted material.

III.- That the DEPONENT is submitting the PROJECT as AUTHOR. If the authorship of the PROJECT corresponds to more than one author, the DEPONENT guarantees SIXBIRDS that each author has knowledge of and gives their consent to the submission of the PROJECT to SIXBIRDS under the established terms in this document and is committed to provide the appropriate documentation within a period of no more than fifteen (15) days after the signing.

IV.- The DEPONENT guarantees SIXBIRDS that the PROJECT is an original idea, free of charges and encumbrances and, in particular, has not been previously developed by a third party nor presented, either directly or through an intermediary, under the same title or a different title, to any national or autonomous television network, for a competition or grant, or to any other film production entity. The DEPONENT is bound to hold SIXBIRDS harmless of any claims related to the PROJECT and its originality.

V.- The DEPONENT waives all action and judicial or extrajudicial claims against SIXBIRDS with regards to the violation of copyright, plagiarism and/or use of material in any public domain which could be included in the PROJECT.

VI.- In consideration for reviewing the PROJECT, the DEPONENT grants SIXBIRDS, which accepts, the right of first refusal over all rights related to the exploitation of the PROJECT, all modality, support and system (present and future), all over the world and during the entire period of legal protection of such rights, including but not limited to its posting, reproduction, distribution, public display, public disposition through wireless and non-wireless procedures, transformation, dubbing and subtitling in all languages. SIXBIRDS disposes of a period of sixty (60) days following notification to the DEPONENT of its interest in the development of the PROJECT for the exercise of such rights. The terms of purchase will be determined through mutual accord.

VII.- This document is granted the protection of the Spanish mercantile legislation and in particular the modified text 1/1996 of the Copyright Law. All parties shall submit the knowledge of any litigious questions related to this document to the jurisdiction of the Barcelona court system.
